#### PERSONAL DATA RETENTION

Depending on the processing activity, we may store your personal data from 1 month up to 10 years, based on the nature of data processed, the legal basis, the purpose of processing and legal obligations of GOlegal.

### WHAT ARE YOUR RIGHTS AS DATA SUBJECTS?

## **Implementing your rights**

Should you have any questions, remarks or complaints about how we process your personal data, please contact the following e-mail address: <a href="mailto:privacy@golegal.law">privacy@golegal.law</a>. Through the implementation of dedicated process, we will then acknowledge receipt of your request and answer it within 1 month of the receipt. Exceptionally, this term may be extended up to 3 months, but we will justify it in the initial 1 month term.

Please care about being clear on which right you wish to exercise and through which channel you wish to receive the information. We may need additional information to authenticate you as data subject (such as ID).

The answer given to your request will always depend on the purpose of processing, the legal basis, the context and other obligations of GOlegal.

## Right to access

You have the right to request access to all personal data processed by us to you. Subsequent requests for access addressed to us that are manifestly submitted for causing nuisance or harm to us, will not be dealt with.

## Right to rectification

You have the right to ask that any personal data pertaining to you that are inaccurate, are corrected free of charge. If you have registered with our website/service, you can correct a lot of these data yourself via your profile. If a request for correction is submitted, such request shall be accompanied of proof of the flawed nature of the data for which correction is asked.

# Right to object

You have the right to oppose the processing of personal data if you are able to proof that there are serious and justified reasons connected with the particular circumstance that warrant such opposition. However, if the intended processing qualifies as direct marketing, you have the right to opt out of such processing free of charge and without justification.

# Right to restriction

You can also ask that we limit the processing of your personal data if and when (a) you contest the accuracy of that data, (b) the processing is illegitimate or (c) the data are no longer needed for the purposes listed but you need them to defend yourself in judicial proceedings.

# Right to erasure ("Right to be forgotten")

You have the right to request that personal data pertaining to you be deleted if they are no longer required in light of the purposes outlined in this notice or if you withdraw your consent for processing them. However, you need to keep in mind that a request for deletion will be evaluated by us against legal or regulatory obligations or administrative or judicial orders which may contradict such deletion.

## Right to withdrawal

You have the right to withdraw your earlier given consent for processing your personal data. You can withdraw your consent at any time by sending an email to the following address: <a href="mailto:privacy@golegal.law">privacy@golegal.law</a>.

## Right to portability

Where your personal data is processed based on consent or based on a contract and the processing is carried out by automated means, you have the right to receive your personal data in a structured, commonly used and machine-readable format and, where technically feasible, you will have the right to directly transmit those data to another service provider.
