#### WHAT IS A COOKIE?

Cookies are small text files that are stored on a device's hard drive and contain certain information and sometimes personal data. When we process personal data through the use of cookies, this processing is undertaken as described in our <u>Privacy Notice</u>.

Information is recorded in a text file, such as your choice of language for a website. When you visit the website again later, this cookie is sent back to the site in question. In this way, the website recognises your browser and can remember your choice of language, for example.

Cookies generally also have an expiry date. Some cookies, for example, are automatically deleted when you close your browser (so-called session cookies), while others remain on your computer for longer, sometimes even until you delete them manually (so-called permanent cookies).

#### WHY DO WE USE COOKIES?

GOlegal, which manages this website, may use three types of cookies on www.golegal.law:

- Essential cookies
- Functional cookies
- Analytical cookies

To manage the content of its website, GOlegal may set <u>essential</u> and <u>functional</u> cookies. These cookies are necessary for the proper functioning of this website. It is not possible to refuse these cookies if you wish to visit our website. Such cookies are exempt from the requirement for consent, in accordance with article 129 of the law of 13 June 2005 on electronic communications (see points 3.1. and following the 04/2012 opinion of Working Party 29). GOlegal may also use cookies for <u>analytical</u> purposes. In particular, this allows us to know how many times a given page has been consulted. We only use this information to improve the content of our





website or as a basis for a new campaign on a certain topic that generates a lot of interest. These analytical cookies are installed on our own servers and may be managed by third parties with your consent. If you refuse the use of these type of cookie, only those pages and services that do not need these cookies can be displayed, viewed and used. The parts of the website that allow the inclusion of third-party content – and therefore of analytical cookies – will no longer be accessible and a message will inform you of this.

These cookies are necessary for purely technical reasons in order to enable you to visit the website normally. Given the technical necessity, only an obligation to provide information applies, and these cookies are placed as soon as you access the website.
